What is the primary goal?	<p>The primary goals of the SWG are to:</p> <ul style="list-style-type: none"> <li>Facilitate implementation of the 5010 27x transactions</li> <li>Provide a forum to address business issues related to the implementation of the 5010 27x transactions; and</li> <li>Create white papers and provide audio-casts, educational guidance, etc on issues related to the implementation of the 5010 27x transactions</li> </ul>
What business problem will be minimized or resolved by this workgroup?	The SWG will minimize implementation business issues of the 5010 27x transactions
Stakeholders	Providers, payers, clearinghouses, vendors, and other entities sending or receiving the 5010 27x transactions
Describe the central problem this project will attempt to resolve. What are some of the symptoms of this problem? Are there any corollary problems?	The primary issue the SWG will address is the overall implementation of the 5010 27x transactions. This SWG will also attempt to drive wider adoption of the eligibility, claim status, referral and pre-authorization transactions.

The implementation of the 5010 270/271, 276/277, and the 278 Health Care Services Review and Response transactions is required by HHS regulation. All covered entities will be required to use the 5010 270/271, 276/277, and the 278 Health Care Services Review and Response transactions as of January 1, 2012. The use of the 4010 270/271, 276/277, and the 278 Health Care Services Review and Response transactions will not be compliant after this date.
